VOLUNTARY SURRENDER OF LICENSE,
AGREEMENT FOR ADJUDICATION OF FEES AND
ASSESSMENT OF ADMINISTRATIVE FINE

T & B MOBILE HOME MOVERS, LLC, acting by and through its Manager, Bryan T. Adair, having been fully advised of the charges of possible violations of the Mississippi Code and the right to a hearing as provided in Miss. Code Ann. §§ 75-49-13 and 75-49-19 (Supp. 2011) and understanding that it is entitled to a hearing before the Commissioner of Insurance of the State of Mississippi to determine the reasonableness of the Commissioner's action, does hereby admit to the allegations contained in the Amended Notice of Hearing and Statement of Charges dated November 15, 2012, waives the right to a hearing and consents to voluntarily surrender T & B Mobile Home Movers, LLC's Mississippi Retailer License No. 15009486 and Installer/Transporter License No. 401170, to act as a Manufactured Home Retailer and/or Installer/Transporter in the State of Mississippi, effective immediately.

T & B Mobile Home Movers, LLC also agrees to cease and refrain from engaging in the construction, sale, transportation or installation of a factory-built home intended to be used for human habitation, until such time as it may obtain a license from the Commissioner of Insurance for the State of Mississippi as required by § 75-49-9 of the Mississippi Code of 1972, as amended, and it is understood that engaging in such conduct without first obtaining an appropriate license will constitute a criminal violation of § 75-49-19(4) of the Mississippi Code of 1972 as Amended.

T & B Mobile Home Movers, LLC further consents and agrees that it is indebted to the Mississippi Insurance Department for delinquent inspection fees, in the total amount of Two Thousand Four Hundred Dollars (\$2,400), now due and payable.

T & B Mobile Home Movers, LLC further consents and agrees that it be, and hereby is, assessed an Administrative Fine in the amount of One Thousand Five Hundred Dollars (\$1,500), payable to the Mississippi Insurance Department.


This Voluntary Surrender of License, Agreement for Adjudication of Fees and Assessment of Administrative Fine is in lieu of any other administrative action by the Mississippi Insurance Department related to this matter, and otherwise finally resolves this matter. Payment of the aforementioned must be submitted to the Mississippi Insurance Department, P.O. Box 79, Jackson, MS 39205.
