## CONSENT TO CIVIL PENALTY

The above stated licensee has been fully informed of alleged noncompliance with Miss. Code § 75-49-1 et. seq. (The Uniform Standards Code for Factory-Built Homes Law), and 19 Miss. Admin. Code, Part 7, Chapter 5 (Rules and Regulations for the Uniform Standards Code for the Factory Built Homes Law – Regulation MH-5), a brief statement of the specific violation being as follows:

Failure to Submit Required Property Locator / Certificate of Installation form to the Office of the State Fire Marshal within the time allowed (Two (2) Separate Violations).

Understanding that I am entitled to a hearing before the Commissioner of Insurance of the State of Mississippi to determine the reasonableness of the Commissioner's action, I do hereby consent, in lieu of such hearing, to the following terms and conditions:

- 1) Licensee agrees to the imposition of an administrative fine payable to the Mississippi Insurance Department in the amount of \$500.00, due and payable upon execution of this document.
- 2) Licensee agrees to henceforth submit the required Property Locator / Certificate of Installation as required, within 72 hours (3 days) of the installation of any factory built home sold by Licensee.

This Consent to Administrative Penalty is being tendered in lieu of other possible administrative action by the Department of Insurance of the State of Mississippi / State Fire Marshal, Factory-Built Home Division.

I fully understand that should I fail to follow the terms of this Consent to Civil Penalty as agreed, that an administrative hearing may be set by the Commissioner of Insurance and administrative action may be taken against me as provided in *Miss. Code § 79-49-19*, and that such hearing could potentially result in the revocation of my license and a civil penalty of not more than \$1,000 for each violation of law.
