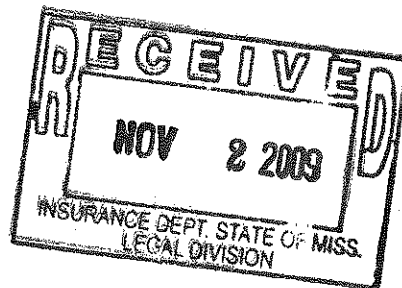
Dear Mr. Bois:

The Mississippi Department of Insurance received Censtar Title Insurance Company's Jurat Page on June 11, 2009 and your company's filing with the NAIC was received on May 18, 2009.

### **AUTHORITY**

Pursuant to Miss. Code Ann. §83-5-55 (2) (Supp. 2008), "Every insurance company **shall** file with the Commissioner of Insurance, a quarterly statement showing the business standing and financial condition of the company for that quarter..." "Each quarterly statement shall be filed within forty-five (45) days of the last day of the quarter."

Pursuant to Miss. Code Ann. §83-5-69 (Supp. 2008), "Any company that neglects to make and file its quarterly and annual statement within the time provided in this chapter **shall** pay to the Commissioner of Insurance One Hundred Dollars (\$100.00) for each day's neglect; and upon notice by the Commissioner to that effect, its authority to do new business **shall** cease while such default continues..."

**STATEMENT OF CHARGES**


